

**United Brotherhood of Carpenters and Joiners of America
Residential Carpenters Local # 1070 Application for Referral**

Conditions of Membership

Be advised that all new members or previous members who are renewing their membership that are accepted as members of United Brotherhood of Carpenters and Joiners of America Residential Local Union # 1070 (hereinafter referred to as Carpenters Local # 1070) must agree to adhere to the following conditions of membership:

1. All new members or previous members who are renewing their membership that are accepted as members of Carpenters Local # 1070 are required to maintain their membership in Carpenters Local # 1070 for a minimum of five (5) years before being eligible for transfer of membership to any other Local Union affiliated with the United Brotherhood of Carpenters and Joiners of America;
2. All new members or previous members who are renewing their membership that are accepted as members of Carpenters Local # 1070 that wish to transfer their membership after the five year period mentioned above will be subject to the membership admittance policy required by the United Brotherhood of Carpenters and Joiners of America Regional Council or Local Union that said member of Carpenters Local # 1070 wishes to transfer to;
3. All new members or previous members who are renewing their membership that are accepted as members of Carpenters Local # 1070 further agree to abide by the Constitution and Bylaws of the United Brotherhood of Carpenters and Joiners of America, The Mid-Atlantic Regional Council of Carpenters, and the Mid-Atlantic Regional Council of Carpenters West Virginia District.
4. All new members or previous members who are renewing their membership that are accepted as members of Carpenters Local # 1070 also agree to abide by the Labor Agreement entered into between any contractor and Carpenters Local # 1070;
5. Applicants for membership that have not previously been members of the United Brotherhood of Carpenters and Joiners of America or Carpenters Local # 1070 will be required to complete a 30 day probationary period at a reduced pay rate as defined by the Labor Agreement when hired on their first job with a signatory contractor.
6. Any false statements or representations made by an applicant on this application form will constitute cause for dismissal from employment and refusal of membership in Carpenters Local # 1070.
7. Submittal of this application to Carpenters Local Union # 1070 shall constitute **acceptance of the Conditions of Membership by the applicant.**
